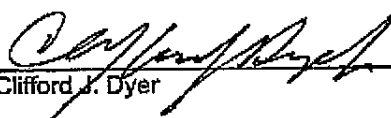
Article VII. Regulations.

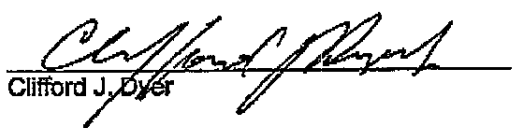
