ARTICLES OF AMENDMENT (name change) OF NBTC MANAGEMENT, LLC

NBTC MANAGEMENT, LLC a Florida Limited Liability Company

NBTC MANAGEMENT, LLC, a Florida limited liability company, organized under the laws of the State of Florida on September 13, 2000, and having its principal office at 4995 Airport Road, North, Naples, Florida 34105 (the "Company"), hereby certifies to the Department of State of Florida, that:

FIRST: The Articles of Organization of the Company hereby are amended by deleting Paragraph 1 of the said Articles and inserting in lieu thereof the following:

"1. NAME: The name of the Limited Liability Company is Naples Bath & Tennis Club, LLC (the "Company")."

FIRST AMENDMENT TO OPERATING AGREEMENT (name change)

THIS FIRST AMENDMENT TO OPERATING AGREEMENT is made as of the day of April, 2001, by CONTINENTAL REALTY INVESTORS CORP., a Maryland corporation, in its capacity as the Manager of NBTC MANAGEMENT, LLC (the "Company").

WITNESSETH:

WHEREAS, pursuant to the Articles of Organization filed on September 13, 2000, the Company was organized as a Florida limited liability company; and

WHEREAS, pursuant to an Operating Agreement dated September 13, 2000 (the "Operating Agreement"), the Company exists pursuant to the terms and conditions of the Operating Agreement; and

WHEREAS, pursuant to Paragraph 9 of the Operating Agreement, the Manager of the Company is Continental Realty Investors Corp. (the "Manager"); and

WHEREAS, pursuant to Paragraph 9 of the Operating Agreement, the Manager has the exclusive authority to make all decisions on behalf of the Company and execute documents as may be required by the Company;

NOW, THEREFORE, pursuant to the authority granted to the manager under Paragraph 9 of the Operating Agreement, the Operating Agreement is hereby amended as follows, effective immediately:

- 1. The name of the Company hereby is changed from NBTC Management, LLC to Naples Bath & Tennis Club, LLC.
- 2. Except as modified herein, the terms and conditions of the Operating Agreement shall remain unchanged and in full force and effect.
