Management of the Company

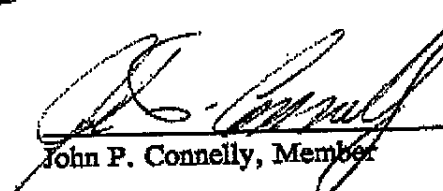
The Company shall be managed by its members in the manner set forth in the Company's Operating Agreement.

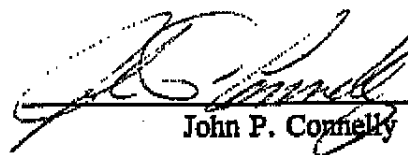
