#### ARTICLES OF ORGANIZATION

**OF** 

#### KERNEY HOLDINGS, LLC

#### ARTICLE I

#### <u>NAME</u>

The name of this limited liability company (the "Company") shall be **KERNEY HOLDINGS**, **LLC** and its mailing address and principal place of business is 320 SE 16th Ave., Ft. Lauderdale, Florida 33301.

#### **ARTICLE II**

#### **COMMENCEMENT OF EXISTENCE**

This Company shall commence existence on the date these Articles are filed with the Florida Department of State and shall have perpetual existence unless sooner dissolved in accordance with the Regulations of the Company or according to law.

Additional Members may be admitted from time to time on such terms and condition determined by the Managers. No current Member has any preemptive rights.

#### ARTICLE VIII

## DEATH, RETIREMENT, RESIGNATION, BANKRUPTCY, EXPULSIONS DISSOLUTION OF MEMBER

In the event of the death, retirement, resignation, bankruptcy, expulsion or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Company, the Managers may continue the business of the Company without a vote of the Members so long as there is at least one remaining Member of the Company.

#### ARTICLE IX

#### **AMENDMENT**

The right to amend or repeal any provisions contained in these articles of organization, or any amendment hereto, is conferred upon the Managers.

#### **ARTICLE X**

#### **HEADINGS AND CAPTIONS**

The headings or captions of these various articles of organization are inserted for convenience and none of them shall have any force or effect, and the interpretation of the various articles shall not be influenced by any of said headings or captions.
