ARTICLES OF ORGANIZATION OF ASI TECHNOLOGY PRODUCTIONS, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I

Name. The name of the limited liability company shall be ASI TECHNOLOGY PRODUCTIONS, LLC ("Company").

ARTICLE II

Address. The mailing address and street address of the principal office of the Company shall be 15519 West U.S. Highway 441, Building 206B, Eustis, FL 32726.

ARTICLE III

<u>Duration</u>. The Company shall commence its existence on the date these <u>Articles of Organization are filed by the Florida Department of State</u>. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in the operating agreement of the Company.

ARTICLE IV

Initial Registered Office and Agent. The street address of the initial registered office of the Company is 1132 Symonds Avenue, Winter Park, FL 32789 and the name of the initial registered agent of the Company at that address is GARY M. BERKSON.

ARTICLE V

Management. The Company shall be managed by a manager or managers in accordance with an operating agreement adopted by the members for the management of the business and affairs of the Company. The operating agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.
