ARTICLES OF ORGANIZATION

FOR

GOLD'S GYM SUNCOAST ALLIANCE, LLC

ARTICLE I - Name

The name of this limited liability company shall be GOLD'S GYM SUNCOAST ALLIANCE, LLC.

ARTICLE II - Duration

The limited liability company shall have a perpetual existence.

ARTICLE III - Purpose and Powers

Except as restricted by these Articles of Organization, this limited liability company is organized to operate a trade alliance amongst Gold's Gyms as well as for each and every legal and lawful purpose for which a limited liability company may be organized pursuant to the Florida Limited Liability Company Act.


