#### ARTICLES OF ORGANIZATION OF

## ARTICLE I

The name of this Limited Liability Company shall be <u>LATIN MULTIMEDIA</u> <u>INVESTMENTS, L.L.C.</u> (the "Company").

## ARTICLE II

The Company shall be terminated and dissolved upon:


- (A) the vote of all members holding an interest in the Company;
