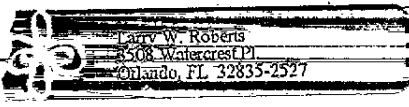

ARTICLES OF ORGANIZATION

PAPA JOHN'S OF CENTRAL FLORIDA, LLC **A Florida Limited Liability Company**

ARTICLE I **NAME**

MEMBERS' RIGHT TO CONTINUE BUSINESS**




**CERTIFICATE OF DESIGNATION
