ARTICLES OF ORGANIZATION

The undersigned, being a duly authorized representative of a member, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I NAME

The name of the Limited Liability Company is *Riverwhite, L.L.C.* (the "Company").

ARTICLE II ADDRESS

The mailing address and street address of the principal office of the Combany is c/o 3301 Ponce de Leon Blvd., Suite 200, Coral Gables, FL 33134

ARTICLE III DURATION AND CONTINUATION

The period of the Company's duration shall commence with the filing of these Articles of Organization with the Secretary of State and shall continue perpetually unless terminated: (1) in accordance with the Company's Regulations; (2) by the unanimous written agreement of all Members; (3) by the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member; or (4) upon the occurrence of any other event which terminates the continued membership of a Member. However, upon any such termination event, the existence and business of the Company may be continued with the consent of a majority of the remaining Members of the Company or by amendment of these Articles of Organization providing for the continued existence of the Company.

ARTICLE IV PURPOSE

The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE V MANAGEMENT

The Company shall be managed by one manager and is, therefore, a manager-managed company. The name and address of the initial manager is:

The Manager shall serve in such capacity until the first annual meeting of the Members or until his successor is duly elected and qualified. The Manager shall conduct, carry on and manage the Company in the manner prescribed by and provided in the Regulations of the Company and the laws of the State of Florida. The Manager shall also have the rights and responsibilities described in the Company's Regulations.

ARTICLE VI ADDITIONAL MEMBERS

Additional Members may be admitted upon the approval of a majority of the Members of the Company, upon the written application of such new Member, in the manner set forth in the Regulations of the Company.

ARTICLE VII REGULATIONS

The power to adopt, alter, amend or repeal the Regulations of the Company shall be vested in the Members of the Company.

ARTICLE VIII REGISTERED AGENT, REGISTERED OFFICE, & REGISTERED AGENT'S SIGNATURE
