
ARTICLE VIII - MANAGEMENT



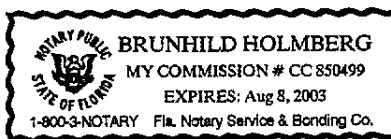
