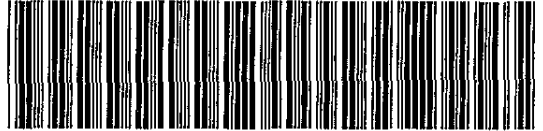

**FIRST:** The Articles of Organization were filed on 9/20/2000 and assigned document number L00000011444.

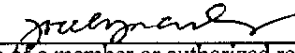
**SECOND:** This amendment is submitted to amend the following:
