**ARTICLES OF ORGANIZATION**  
**OF**  
**SPHERE, L.L.C.**

The undersigned hereby certifies that the members have associated together for the purpose of becoming a limited liability company under Chapter 608 of the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. The undersigned further declare that the following Articles shall be the Charter and authority for the conduct of business of such limited liability company.

**ARTICLE I**

**Name**

**Duration**

**Initial Registered Office and Agent**

**ARTICLE V**

**Members Rights to Continue Business**

The members are further expressly authorized to add to, delete from or otherwise amend the Operating Agreement of this company.

## ARTICLE IX

### Purposes and Powers

This limited liability company is organized for the following purposes and shall have the following powers:

- A. To engage in any activity or business authorized under Florida Statutes.
- B. To own real and personal property, to enter into contracts and agreements, and to engage in any lawful business necessary or appropriate authorized under these Articles of Organization.
- C. To invest its funds in real estate, mortgages, stocks, bonds and any other types of investments permitted by law.
- D. To do everything necessary, proper or convenient for the accomplishment of the purposes set forth herein, and to do every other act incidental thereto which is not forbidden under the laws of the State of Florida, or by the provisions of these Articles of Organization.

## ARTICLE X

### Amendment

These Articles of Organization may be amended by a vote of members representing Fifty One Percent (51%) of the ownership interest in this limited liability company.
