

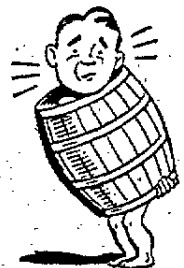

**ARTICLES OF ORGANIZATION
TRACY DELIVERY, LLC**

ARTICLE I. – NAME

The name of this Limited Liability Company is "Tracy Delivery, LLC." It is referred to in these Articles of Organization as the "Company."

ARTICLE IV. – MANAGEMENT


Management of the Company is vested in the members in accordance with these Articles, or such operating agreement agreed to by the members of the Company, or the Florida Limited Liability Company Act.
