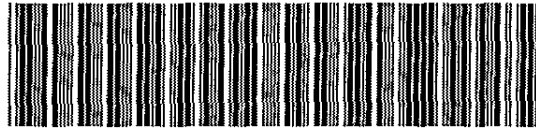


1. The name of the limited liability company is CEA EVOLUTION HOLDINGS, LLC (the "Company").
