ARTICLES OF ORGANIZATION OF

ARTICLE I

NAME

The name of this Limited Liability Company shall be QUICK CLAIMS ON LINE, L.L.C. (the "Company").

DURATION


The Company shall be terminated and dissolved upon:


- (A) the vote of all members holding an interest in the Company;

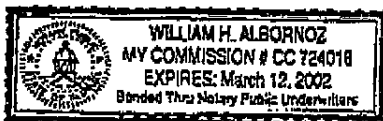

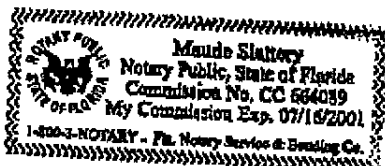
