**ARTICLES OF ORGANIZATION OF
JAZZTEL PARAGUAY, L.L.C.
A FLORIDA LIMITED LIABILITY COMPANY**

THE UNDERSIGNED, THOMAS TURPIE, pursuant to Florida Statutes 608.407 does hereby execute these Articles of Organization of JAZZTEL PARAGUAY, L.L.C. ("the Limited Liability Company") for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act and do hereby state and set forth:

1. The name of the Limited Liability Company is JAZZTEL PARAGUAY, L.L.C.
2. The purpose to the Limited Liability Company is to conduct any and all lawful business.
3. The period of duration of JAZZTEL PARAGUAY, L.L.C. shall be perpetual.
4. The mailing address and street address of the principal office of the Limited Liability Company is 110 East Broward Boulevard, Suite 680, Fort Lauderdale, Florida 33301.
5. The name of the initial registered agent in Florida for the Limited Liability Company is THOMAS TURPIE and the registered office is located at 110 East Broward Boulevard, Suite 680, Fort Lauderdale, Florida 33301. The acceptance of THOMAS TURPIE as registered agent appears after the execution of these Articles of Organization below.
6. No members shall be allowed to admit additional members except by a unanimous vote of the voting members of the Limited Liability Company, or upon such greater vote as may be prescribed by the Limited Liability Company regulations.
7. The Limited Liability Company shall not dissolve and the remaining members of the Limited Liability Company shall continue its business upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Limited Liability Company.
8. The management of the Limited Liability Company is reserved to its voting members. The name and address of the voting member of the Limited Liability Company is:

All other matters regarding the relative rights of the voting and non-voting members of the Limited Liability Company, and the operations of the Limited Liability Company shall be determined by the Limited Liability Company regulations. The power to adopt, alter, amend, or repeal the regulations of the Limited Liability Company shall be vested in the voting members of the Limited Liability Company.
10. Members of the Company have the right to admit new members. Additional members may be admitted only on the unanimous written consent of the existing members, and the existing members shall determine the amount and nature of contributions by new members at the time the new members are admitted.
