## ARTICLES OF ORGANIZATION FOR LIMITED LIABILITY COMPANY

These are the Articles of Organization of the G.W. Bennett & Company, L.C., and are executed by the undersigned persons for the purpose of forming a Florida limited liability company under the Florida Limited Liability Company Act.

To carry on a general investment and management consultant and advisory business relating to investments and the operation of businesses, plants, properties, and real and personal property of every kind, in the United States and foreign countries, subject to the applicable laws

thereof. To maintain executive and operating personnel for the purpose of consulting with and advising others in all matter relating to investments and the management and operation of businesses and other properties of every kind. To furnish business investment and management plans and programs, to formulate policies, and generally to advise and assist others, under contract or otherwise, in the management of their businesses, plants, properties and investments. To buy and sell projects and developments on its own behalf and on behalf of others in connection with the operation, management and development of individual and corporate businesses.
