1. The name of the Company is STORM RADAR, L.L.C. The Articles of Organization of the Company were filed with the Secretary of State of the State of Florida on September 26, 2000.
2. These Amended and Restated Articles of Organization restate, integrate and amend the provisions of the Company's Articles of Organization including, without limitation, to reflect the withdrawal of Scott P. Stevens as a member of the Company.
3. The terms and provisions of these Amended and Restated Articles of Organization were adopted by the members of the Company pursuant to a written action without a meeting executed as of and effective December 18, 2001.
4. The Articles of Organization of the Company are hereby amended and restated in their entirety as follows to (i) change the principal office address of the Company, (ii) change the designation of the Company's registered agent, and (iii) to delete Article IV in its entirety to render such Article further force or effect:

III.


