# ARTICLES OF ORGANIZATION OF

# IRWIN CONTRACTING OF EAST FLORIDA, LLC

A Florida Limited Liability Company

The undersigned (the "Member") acting as the organizer of Irwin Contracting of East Florida, LLC, ("Company") under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopts the following Articles of Organization:

#### ARTICLE 1

#### NAME

The name of the limited liability company is:

#### **ARTICLE 2**

# PURPOSE AND POWERS

- A. <u>Purposes</u>. The Company is organized for any legal and lawful purpose for which a limited liability company may be organized pursuant to Chapter 608, Florida Statutes, as the same may be amended from time to time.
- B. <u>Powers</u>. The Company shall have and may exercise all powers and rights which a limited liability company may exercise pursuant to Chapter 608, Florida Statutes, as the same may be amended from time to time.

#### **ARTICLE 3**

# INITIAL REGISTERED AGENT, AND REGISTERED OFFICE ADDRESS AND PRINCIPAL OFFICE OF THE COMPANY

- A. <u>Initial Registered Agent and Office</u>. The initial registered agent for the Company to receive service of process is Ian F. Irwin. The street address of the Company's initial registered office is 222 Second Street North, St. Petersburg, FL 33701.
- B. <u>Principal Place of Business</u>. The street address of the Company's principal office is 222 Second Street North, St. Petersburg, FL 33701. The mailing address shall be the same.

#### **ARTICLE 4**

#### <u>ADMISSION OF NEW MEMBERS</u>

The Company shall admit new Members only upon the unanimous written consent of existing Members of the Company.

#### ARTICLE 5

#### **MANAGER**

The name and business address of the initial Manager of the Company is: 4I, LLC, 222 Second Street North, St. Petersburg, FL 33701. Should the foregoing named Manager be unable to serve in this capacity, in such event the business of the Company shall be managed by a Manager elected by the Members holding seventy-five (75%) of the then outstanding contributed and not returned capital of the Company. The Manager is required to be a Member of the Company. The Manager shall have the power and authority to act on behalf of the Company as provided in Chapter 608, Florida Statutes, as the same may be amended from time to time, and further provided in the Operating Agreement adopted by the Company.

#### ARTICLE 6

#### PERIOD OF DURATION

The Company's existence shall commence upon the acceptance of these Articles of Organization by the Secretary of State of Florida for filing in accordance with §608.4081, Florida Statutes, and shall be perpetual, unless dissolved in accordance with the terms of the Operating Agreement adopted by the Company.

# ARTICLE 7

#### **CONTINUATION OF BUSINESS**

The remaining Member or Members of the Company shall have the right to continue the business of the Company upon the retirement, resignation, expulsion, bankruptcy or dissolution of a Member.

### **ARTICLE 8**

# **AMENDMENTS**

The Company reserves the right to amend any provision of these Articles of Organization, which amendment shall only be effectuated by the written approval by a majority of the Members of the Company and the approval of the Manager of the Company.

# ADOPTION OF OPERATING AGREEMENT

The Company shall adopt an Operating Agreement which may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with these Articles of Organization, or Chapter 608, Florida Statutes.

In accordance with §608.408(3), Florida Statutes, the execution of this affidavit constitutes an affirmation under penalties of perjury that the facts stated herein are true.
