ARTICLES OF ORGANIZATION

OF

A Florida Limited Liability Company

ARTICLE 1

NAME

The name of this Limited Liability Company is: Bunnell Sod, L.L.C.

ARTICLE 2

DURATION

The duration of this limited liability company is perpetual from the date of commencement of the limited liability company's existence. 
