

This limited liability company shall have all of the powers enumerated in the Florida General Limited Liability Company Act.

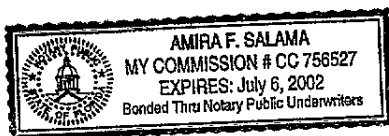
