ARTICLES OF ORGANIZATION

OF

# THE ROBISON COMPANY, L. L. C.

The undersigned certify that we have associated ourselves together for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. We further declare that the following Articles shall serve as the Charter and authority for the conduct of business of the limited liability company.

# ARTICLE I. NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the limited liability company shall be THE ROBISON COMPANY, L. L. C., and its principal office and mailing address shall be located at 1407 E. 2<sup>nd</sup> Street, Sanford, Florida 32771, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.
