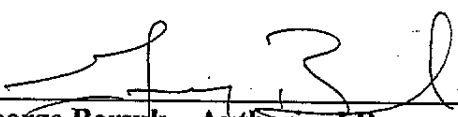
ARTICLE III – Duration

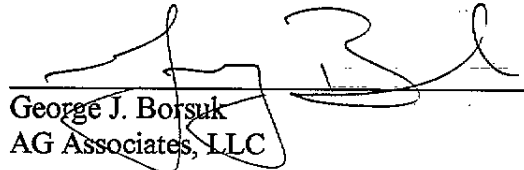
