The name of the limited liability company shall be HQM of Springfield, L.L.C. ("Company").

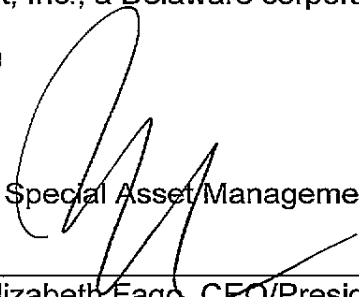
ARTICLE VIII – MANAGEMENT/MANAGING MEMBER
