# ARTICLES OF ORGANIZATION OF THE H2O ZONE, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

### **ARTICLE I - NAME**

The name of the limited liability company shall be THE H2O ZONE, LLC ("Company").

## ARTICLE II - ADDRESS

## **ARTICLE III - DURATION**

The Company shall commence its existence on the date the Articles of Organization were filed by the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in these Restated Articles of Organization.

## ARTICLE IV - REGISTERED OFFICE AND AGENT

#### **ARTICLE V - MANAGEMENT**

The Company shall be managed by managers in accordance with the Operating Agreement adopted by the members for the management of the business and affairs of the Company. The Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.
