ARTICLES OF ORGANIZATION OF CHARLES A. STAMITOLES, D.D.S., P.L.

The undersigned, for the purpose of forming a professional limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608 and the Professional Service Corporation and Limited Liability Company Act, F.S. Chapter 621, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the professional limited liability company shall be CHARLES A. STAMITOLES, D.D.S., P.L. ("Company").

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the Company shall be 1025 Creighton Road, Suite 101, Pensacola, Florida 32504.

E. To do everything necessary and proper in accomplishing the purposes herein set forth and to do anything incidental thereto which is not forbidden under the laws of the State of Florida.

ARTICLE VI - TERMINATION OF EXISTENCE


