**SECOND:** The following amendment to the articles of organization was adopted by the limited liability company:

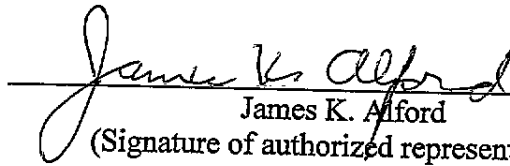
Article I of the Articles of Organization is hereby amended to change the name of HWM Enterprises, LLC to GHP (Honduras) LLC and shall be read as follows:
