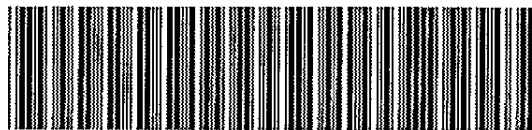

**AMENDED AND RESTATED  
ARTICLES OF ORGANIZATION OF  
MOSQUITOES ~ NO MORE, L.L.C.**  
(filed in accordance with 608.411, F.S.)

**ARTICLE I**

Name and Date of Filing

The name of the limited liability company is Mosquitoes~No More, L.L.C. (hereinafter "Company"). The date of the filing of the initial Articles of Organization was October 2, 2000.

**ARTICLE II**

Limited Liability

The members of this Company shall have limited liability.

**ARTICLE III**

Address

The mailing and street address of the Company is 6510 Chardonnay, Pensacola, FL 32504.

**ARTICLE IV**

Duration

The period of duration of the Company is perpetual.

**ARTICLE V**

Registered Agent and Office

Effective Date

The effective date of the Company's organization is October 1, 2000.

**ARTICLE VIII**  
Admission of New Members

Members of the Company have the right to admit new members. Additional members may be admitted only on the written consent of a majority of the existing members. The existing members shall determine the amount and nature of contributions by new members at the time the new members are admitted.

**ARTICLE IX**  
Continued Business Upon Death of Members

The remaining members of the Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event, which terminates the continued membership of a member in the Company. The business may be continued only on the written consent of a majority of the remaining members.

**ARTICLE X**  
Additional Provisions

The power to adopt, alter, amend, or repeal the regulations of the Company is vested entirely in the members listed in Article VI.
