## ARTICLES OF ORGANIZATION OF ADVANCED TECHNOLOGY IMAGING SERVICES, L.L.C.

- 1. Name. The name of this limited liability company is ADVANCED TECHNOLOGY IMAGING SERVICES, L.L.C., a Florida limited liability company (the "Company").
