ARTICLES OF ORGANIZATION OF

MERIDIAN SURVEYING & MAPPING, L.L.C.

The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge the file the following Articles of Organization.

ARTICLE I NAME

The name of the Limited Liability Company shall be MERIDIAN SURVEYING & MAPPING, L.L.C. ("Company"). The principal place of business of the Company shall be 816 McKinley Avenue, Lehigh Acres, Florida 33936.
