SECOND: This Amendment hereby changes Article IV of the Articles of Organization so the Company is managed by one or more managers. The name and address of the manager is:

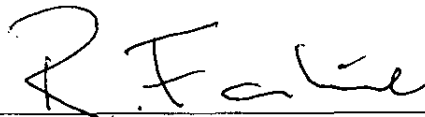
