ARTICLES OF ORGANIZATION

The undersigned being a duly authorized representative and member and acting as the organizer of a limited liability company under and pursuant to the Florida Limited Liability company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I
NAME

The name of the Limited Liability company shall be Premis IT Solutions, L.L.C. (The "Company").

ARTICLE II
DURATION

The period of the Company's duration shall commence on the date of filing these Articles of Organization and shall exist perpetually, unless terminated: (1) in accordance with the Company's Regulations; (2) by the unanimous written agreement of all Members; (3) by the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member; or (4) upon the occurrence of any other event which terminates the continued membership of a member. Upon any such termination, however, the existence and business of the Company may be continued with the consent of all remaining members of the company, or by amendment of these Articles of Organization providing forth continued existence of the Company.
