ARTICLES OF ORGANIZATION

OF

OSI DEVELOPMENT, L.L.C.

These Articles of Organization are made for the purposes of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608.




