- 6. Additional Capital Contribution of Members. Additional capital contributions may be contributed only upon the unanimous vote of the members, and never can an additional capital contribution be required at the request of non-member third parties.
- 7. Admission of Additional Members. Additional members may be admitted with the unanimous consent of the existing members.
- 8. Continuity. The members of this company have the right to continue the business upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member, or occurrence of any other event that terminates the continued membership of a member in this company. Continuation may occur only pursuant to the terms of the operating agreement or under the terms of the Florida Limited Liability Company Act.
- 9. Return of Capital and Distribution of Profits. The members' right to a return of capital shall be determined from the company's books as of the effective date of an interim distribution, sale of the property and/or termination of the company, provided generally accepted accounting practices permit a return without jeopardizing the company's financial solvency. Members agree to share income and surplus according to the percentage of their ownership in the company.

- 10. Withdrawal of a Member. Members agree not to withdraw except pursuant to the terms of the operating agreement or as provided by the provisions of the Florida Limited Liability Company Act.
- 11. Management. The business of this company shall be conducted under the exclusive management of its members, who shall vote according to their proportionate capital interest in this company and shall have exclusive authority to act for this company in all matters.
