**ARTICLES OF ORGANIZATION
OF

The initial Registered Agent shall be Charles D. Robbins, whose address is 2699 South Bayshore Drive, 7th Floor, Miami, Florida 33133.

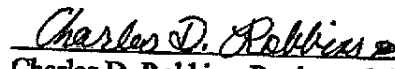
