**ARTICLES OF ORGANIZATION
OF
PROTOSTAR, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I

Name. The name of the limited liability company shall be PROTOSTAR, LLC ("Company").

ARTICLE II

Address. The street address of the principal office of the Company is 1025 South Semoran Boulevard, Suite 1093, Winter Park, Florida 32792, and the mailing address of the Company is Post Office Box 5923, Winter Park, Florida 32793.

ARTICLE III

Duration. The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in the operating agreement of the Company.

ARTICLE IV
