ARTICLES OF ORGANIZATION
OF
DADE CONTRACT DOOR & HARDWARE LLC

Under the Florida Limited Liability Company Law

The undersigned, being a natural person of at least eighteen (18) years of age and acting as the organizer of the limited liability company (the "Company") hereby being formed under the Florida Limited Liability Company Law (the "Florida Law"), certifies that:

FIRST: The name of the Limited Liability Company is Dade Contract Door & Hardware LLC.

SECOND: The mailing address and street address of the principal office of the Limited Liability Company is 1800 New Highway, Farmingdale, New York 11735.

THIRD: In addition to the events of dissolution set forth in the Florida Law, the latest date on which the Company may dissolve is December 31, 2100.



FIFTH: The Limited Liability Company is to be managed by one manager or more managers and is, therefore, a manager-managed company.

SIXTH: A manager shall not be personally liable to the Company or its members for damages for any breach of duty as a manager, except for any matter in respect of which such manager shall be liable by reason that, in addition to any and all other requirements for such liability, there shall have been a judgment or other final adjudication adverse to such manager that establishes that such manager's acts or omissions were in bad faith or involved intentional misconduct or a knowing violation of law or that such manager personally gained in fact a financial profit or other advantage to which such manager was not legally entitled. Neither the amendment nor the repeal of this Article shall eliminate or reduce the effect of this Article in respect to any matter occurring, or any cause of action, suit or claim that, but for this Article, would accrue or arise, prior to such amendment, repeal or adoption of an inconsistent provision.

SEVENTH: The Company shall have the power to indemnify (including but not limited to the advancement of attorney's fees and expenses), to the fullest extent permitted by the Florida Law, as amended from time to time, all persons whom it is permitted to indemnify pursuant thereto.
