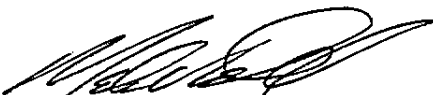
ARTICLE V – Admission of Additional Members:

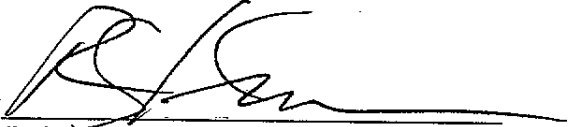
