**ARTICLES OF ORGANIZATION
OF**

DOLPHINS FOUR, L.L.C.
a Florida limited liability company

**ARTICLE I
NAME**

The name of the limited liability company (the "Company") shall be **DOLPHINS FOUR, L.L.C.**, a Florida limited liability company

**ARTICLE II
PRINCIPAL PLACE OF BUSINESS**

**ARTICLE III
REGISTERED OFFICE AND REGISTERED AGENT**

**ARTICLE IV
MANAGEMENT**

The company will be managed by a Manager who shall be designated, appointed or elected as more fully described in the Regulations. The initial number of Managers of the Company shall be one (1). The number of Managers may be increased or decreased in accordance with the terms of the Regulations.

**ARTICLE V
EFFECTIVE DATE**

The Company's effective date of existence shall begin on the date of filing of these Articles with the Florida Secretary of State.

**ARTICLE VI
DURATION**

The Company's duration shall be perpetual. Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of the member, or any other event that would terminate the continued membership of the member in the Company, the remaining members, if any, shall have the right to continue the business of the Company as provided in the Operating Agreement and Regulations.

**ARTICLE VII
ADOPTION OF OPERATING AGREEMENT AND REGULATIONS**

The initial Operating Agreement and Regulations of the Company shall be adopted by its initial member. The Operating Agreement and Regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.

IN WITNESS WHEREOF, the undersigned, being the sole initial member of the Company, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, has executed these Articles of Organization as of this 11th day of OCTOBER, 2000.


