## ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF EEXAM, L.L.C.

Pursuant to the provisions of sections 608.411, Florida Statutes, EEXAM, L.L.C. adopts the following Articles of Amendment to its Articles of Organization (Document No. L000012926), which were filed with the Florida Department of State on October 23, 2000:

FIRST: The name of the company is EEXAM, L.L.C. (the "Company").

**SECOND:** Article I of the Articles of Organization of the Company is amended, in its entirety, to read as follows:

## "ARTICLE II NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the limited liability company shall be ACCELERATED CARE, L.L.C., and its principal and mailing office shall be located at 855 South Federal Highway, Suite 206, Boca Raton, Florida 33432."
