## ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statue 608, hereby make, acknowledge, and file the Articles of Organization.

#### ARTICLE I -- NAME

The name of the Limited Liability Company shall be WATSON HOMES, LLC - (herein referred to as "the company").

#### ARTICLE II -- ADDRESS

#### ARTICLE III - DURATION

All members must become a party to the Limited Liability Company Agreement which outlines the rules and regulations of the Limited Liability Company Agreement or other such regulations of the company, but the transferee shall have not right to participate in the management of the business and affairs of the company or become a member unless the requisite members of the company other than the member proposing the dispose of this or her interest approve of the proposed transfer by written consent.

## ARTICLE VIII - MEMBERS' RIGHT TO CONTINUE BUSINESS

The company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by vote of the remaining members holding at lease 80% of the remaining units.

These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these Articles of Organization.
