ARTICLES OF ORGANIZATION

FOR

SANGELICA, LLC

A FLORIDA LIMITED LIABILITY COMPANY

The undersigned, SAL PELLEGRINO, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the Limited Liability Company is: SANGELICA, LLC

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of this Limited Liability Company is: 2800 Broadway, Riviera Beach, Florida 33440.

ARTICLE III - DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The period of duration for this Limited Liability Company shall be perpetual, unless the company is dissolved earlier as provided in these articles of organization or in the regulations.

ARTICLE IV - MANAGEMENT

Unless and until replaced by the affirmative vote(s) of a member(s) who in the aggregate shall, at the time of such vote, own not less than Fifty-One (51%) Percent of the Limited Liability Company as measured by the relative capital accounts of the member(s), as otherwise provided in the regulations of the Company, the initial managing member of this Limited Liability Company, and the address of such initial managing member, shall be:

ARTICLE V - ADMISSION OF ADDITIONAL MEMBERS:

Additional members may be admitted to the Limited Liability Company only upon the prior written consent on the part of members who, in the aggregate, shall at the time of such vote own not less than Eighty (80%) Percent of the Limited Liability Company as measured by the relative capital accounts of the members.

ARTICLE - VI - MEMBER'S RIGHT TO CONTINUE BUSINESS

Members shall be empowered to continue the business notwithstanding the death, retirement, resignation, expulsion or bankruptcy of a member, including any managing member, and notwithstanding any other event or occurrence which terminates the continued membership of a member in this Limited Liability Company, including any managing member, upon such terms and conditions as shall be established in the regulations or, if none, or if superseded by the approving members, upon such terms and conditions as shall be established by such approving members as condition to their consent and approval.

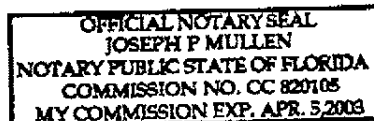
