ARTICLES OF ORGANIZATION

The undersigned, desiring to form a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I. NAME

The name of the limited liability company is **TRUCKERSUCCESS, LLC** (the "Company").

ARTICLE II. ADDRESS

The Company's mailing address and the street address of its principal office is:

Monticello, FL 32344

ARTICLE III. DURATION AND CONTINUATION

The Company's existence will commence on the date of filing of these Articles of Organization with the Florida Secretary of State, and the Company will exist perpetually, unless terminated in accordance with the Company's Regulations.

ARTICLE IV. PURPOSE

The purpose for which the Company is being formed is to acquire, own, develop, lease, sell, finance and otherwise transact business related to motor vehicle sales and service, and to engage in any other activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE V. REGISTERED AGENT AND OFFICE

The Company designates 440 Morris Road, Monticello, Florida 32344 as the street address of the initial registered office of the Company and names G. Ulmer Miller as the Company's initial registered agent at that address to accept service of process within this state.

ARTICLE VI. ADDITIONAL MEMBERS

Additional members may be admitted only upon approval of existing members that own, in the aggregate, more than 50% of the total membership interests in the Company.

ARTICLE VII. MEMBERS RIGHTS TO CONTINUE BUSINESS

The right, if given, of the remaining members of the Company to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event that terminates the continued membership of a member in the Company will be as provided in the Regulations of the Company.

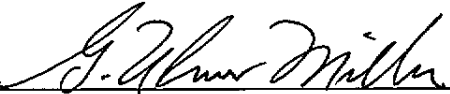
ARTICLE VIII. MANAGEMENT

The Company's affairs will be conducted, carried on, and managed by one or more Managers. Each Manager will retain such position until his or her resignation or until he or she is removed and replaced by the Members of the Company as provided in the Regulations of the Company. The Managers will have the obligations and responsibilities described in the Regulations of the Company. The name of the initial Manager is G. Ulmer Miller, and his address is 440 Morris Road, Monticello, FL 32344.

ARTICLE IX. REGULATIONS

The power to adopt, alter, amend, or repeal the Regulations of the Company will be vested in the members of the Company.
