C- Ray Properties, L.C.

The undersigned, for the purposes of forming a limited liability company under the clorida Limited Liability Company Act, F.S., Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be C- Ray Properties, L.C.
