**ARTICLE I
NAME**

The name of this limited liability company (the "Company") is PET F.R.O.G. SCAN, L.L.C.

**ARTICLE II
DURATION**

The Company may admit new members as provided in the Company's Operating Agreement.

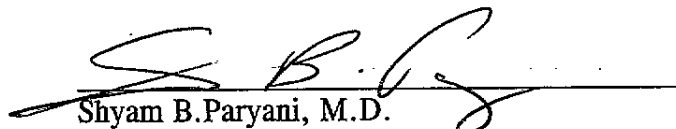
**ARTICLE VIII

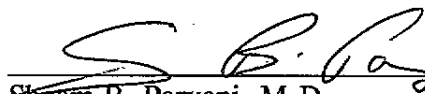
