ARTICLES OF ORGANIZATION

OF

MX FACTORY, LLC

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes (the "Florida Limited Liability Company Act"), for the purpose of forming a Limited Liability Company of the State of Florida do set forth the following: under the laws of the State of Florida do set forth the following:

1. NAME.

PERIOD OF DURATION. 1.
