The Company is a manager-managed company. The initial manager of the Company shall be Lincoln S. LeVarge.

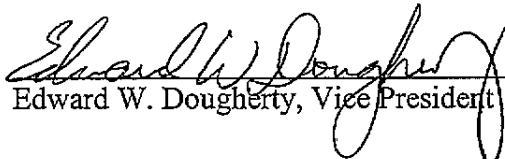
### ARTICLE IV
