

OF

**ARTICLE I**

**NAME**





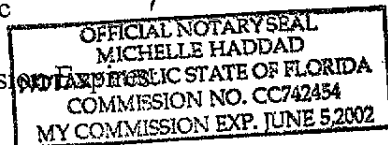
