**ARTICLE VI - MEMBERS RIGHTS TO CONTINUE BUSINESS**

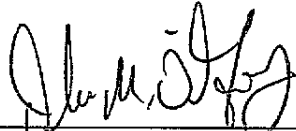

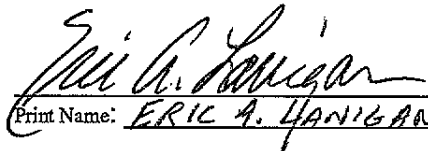
