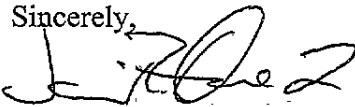

## ARTICLE II – Address

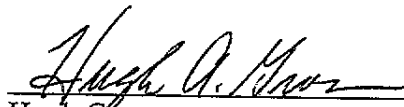

The Limited Liability Company is to be managed by one or more managers and is therefore a manager – managed company.

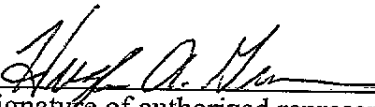

## ARTICLE V – Admission of New Members

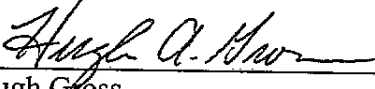
